

### Declaration of compliance for hazardous and/or restricted substances

### To: Customers of TFL

On behalf of TFL affiliates, the following information can be given on the composition of TFL products with respect to hazardous, restricted or reportable substances.

# **Statement regarding Polyfluorinated Substances (PFAS)**

TFL does not intentionally use C8-chain type perfluorinated substances, e.g. PFOS & PFOA in the manufacture of chemicals. In the TFL range there is a very short selection of products based on polymers with fluorinated building blocks though not perfluorooctane sulphonic acid (PFOS) or perfluorooctanoic acid (PFOA) in either the bound or free form. Fluorinated polymer based products are:

- AQUADERM X-SHIELD HO
- AQUADERM X-SHIELD L2
- RODA MOD WP/KN
- PM 4700
- PM 4701
- PM 4800

By selection and cooperation with the raw material suppliers TFL strives to use Polymers with an impurity level of short-chain polyfluorinated substances as low as technically possible.

## Important information:

Trace amounts of currently unavoidable impurities can be present in some TFL chemicals. Manufacturing processes have been optimized to keep the level of these impurities as low as possible. Because of their very low concentration and their chemical nature, these substances are very unlikely to be retained in manufactured leather in concentrations leading to any relevant human exposure during normal use. It should also be noted that leather is a material not designed to release chemical substances during the intended use. Please note that TFL does not analyse all raw materials for residues on a regular basis and that TFL leather chemical are of technical grade.

This Declaration of Compliance shall be valid until superseded by a later version.
